Al	1910	Administrative measures are used to restrict the influx of Asian Indians into California.		
all	1910	Supreme Court extends the 1870 Naturalization Act to other Asians, excluding them from citizenship.		
K	1910's	Large-scale immigration of Korean laborers, picture brides and political refugees to the US.		
all	1924	Exclusionary Immigration Act completely ends Asian immigration, except for Filipinos who are "subjects of the US."		
F	1925	Legislative Act made Filipinos ineligible for US citizenship unless they served three years in the US Navy.		
all	1927-30's	Great Depression coincided with anti-Asian attacks and riots, especially against Filipinos.		
F	1934	Tydigs-McDuffie Act gave the Philippine Islands independence and a US immigration quota of 50 persons per year.		
J	1942-45	Executive Order 9066 puts 110,000 Americans of Japanese ancestry (primarily US citizens) in 10		
		internment camps. Millions of dollars were lost in property and possessions.		
C	1943	Chinese Exclusion Act is repealed.		
С	1947	Amendment to the 1945 War Brides Act allows Chinese American veterans to bring their brides into the US. This increases the number of Chinese women in the US, affecting the predominantly bachelor society that had developed.		
all	1952	A clause of the McCarran-Walter Act grants the right of naturalization to foreign born Asians. A quota of 100 immigrants annually from Asian countries is set.		
all	1965	National Origin Act raises the Asian immigration quota to 20,000 per year. The same as for Europeans.		
all	1967	Anti-miscegenation laws are ruled unconstitutional by the Supreme Court.		
K	1971	Martial law is established in South Korea. Korean immigration increases.		
F	1972	Martial law is established in the Philippines. Filipino immigration increases.		
SE	1975	War in Vietnam concludes. The bulk of 150,000 Indochinese refugees settle in the US These are the "Evacuees."		
Vietnamese	1975-80	Vietnamese settling in the US in this era are largely "Boat People."		
all	1980	US Census reports 3.5 million or 1.5% of the population is Asian American, double the 1970 census.		
J	1989	Pres. George Bush signs into law a reparation program to pay each surviving Japanese American internee \$20,000.		
all	1990	US Census reports 7.3 million or 3% of the population is Asian American, double the 1980 census. This		
		makes Asian Americans the fastest growing segment of the US population.
